

CEDAR CITY RESOLUTION NO. 13-0213

A RESOLUTION OF THE CEDAR CITY COUNCIL TO PREVENT FEDERAL INFRINGEMENT ON THE RIGHT TO KEEP AND BEAR ARMS; TO RENDER NULL AND VOID CERTAIN UNCONSTITUTIONAL ACTS, LAWS, ORDERS, EXECUTIVE ORDERS, RULES, OR REGULATIONS REGARDING FIREARMS THAT ARE A VIOLATION OF THE 2ND AMENDMENT TO THE CONSTITUTION OF THE UNITED STATES OF AMERICA, THAT HAVE BEEN OR MAY BE ENACTED BY THE CONGRESS OF THE UNITES STATES AND/OR THE PRESIDENT OF THE UNITED STATES TAKING CONTROL OVER THE PRIVATE OWNERSHIP, CONFISCATION, REGISTRATION, REGULATION OF CONDITIONS OF OWNERSHIP OF ALL FIREARMS, AMMUNITION, AND ACCESSORIES.

WHEREAS, the 2nd amendment to the Constitution of the United States reads as follows, “a well regulated militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed”.

WHEREAS, federal acts, laws, orders, executive orders, rules, or regulations regarding firearms are an infringement upon and work to erode the freedoms preserved by the 2nd Amendment.

NOW THEREFORE BE IT RESOLVED by the City Council of Cedar City, Iron County, State of Utah that federal act, law, order, executive orders, rules, or regulations regarding firearms that are hereinafter enacted or adopted and that are a violation or infringement of the 2nd Amendment of the Constitution of the United States, passed by the Congress, and/or signed by the President of the United States are to be considered invalid in Cedar City, shall not be recognized by Cedar City, are specifically rejected by Cedar City, and shall be considered null and void and of no effect in Cedar City.

NOW THEREFORE BE IT FURTHER RESOLVED, by the City Council of Cedar City, Iron County, State of Utah that the Cedar City Police Chief is hereby directed to support this Resolution if the federal government, by any agent or officer of any agency of the federal government, attempts to violate the 2nd Amendment Constitutional rights of the City’s citizens.
